Preliminary data for San Diego County in 2009 reveals once again that **suicide is the second leading cause of non-natural death overall.**

To address this important issue, the County of San Diego, Mental Health Services has made a solid commitment to suicide prevention in San Diego County by developing a Suicide Prevention Action Plan (SPAP).

Objectives for the day are to:

- **Identify key components of the *Perfect Depression Care Program.***
- **Discuss and inform the results of the SPAP Needs Assessment.**
- **Participate in the development of strategies for the SPAP.**



Dr. Ed Coffey is a neuropsychiatrist, Henry Ford Health System (HFHS) Vice President and CEO of Behavioral Health Services, and the Kathleen and Earl Ward Chair of Psychiatry, all at the HFHS in Detroit. Dr. Coffey is also Professor of Psychiatry and of Neurology at Wayne State University School of Medicine, HFHS Campus. HFHS has been recently recognized for its advances in suicide prevention through its Perfect Depression Care Program which has accomplished a system wide reduction of over 75%.

Exit Sports Arena/West Mission Bay Drive and turn right at the traffic light - Ingraham Street. Continue on Ingraham Street to the second traffic light - West Vacation Road. Turn left into the hotel main entrance.

I-15 South
